Dear Friends,

On behalf of LifeSpring Health Systems, its staff, Board of Directors, and affiliates I would like to welcome you to our 2015 Annual Report. Thank you for taking time to learn more about our organization and the good work of our dedicated employees. We at LifeSpring Health Systems consider it an honor and a privilege to provide quality healthcare to our communities.

On May 5 of 2015 the U.S. Department of Health and Human Services informed LifeSpring Health Systems that it had been awarded a grant to establish a new access point as a Federally Qualified Health Center (FQHC). LifeSpring is already certified as a Community Mental Health Center and Managed Care Provider by the Indiana Division of Mental Health and Addictions (DMHA). LifeSpring is also an active member of Trillium, a consortium of six Community Mental Health Centers that serve over 32 counties throughout Indiana.

This new funding and designation as an FQHC will go a long way in helping to strengthen the health safety net and helping LifeSpring achieve its goal of being a truly integrated healthcare organization, capable of providing quality services that can meet the complex and diverse healthcare needs of our community.

In 2015, our region also saw the challenge of a major HIV outbreak in Southern Indiana, centered around the small community of Austin in Scott County. This outbreak was found to be associated with high rates of IV opioid abuse. LifeSpring responded by immediately providing increased substance abuse services, including facilitating access to Turning Point Center, our residential substance abuse treatment facility, and by helping to staff Indiana's One-Stop-Shop response center, which was quickly established in Austin. In conjunction with our local partners and funding support from DMHA, LifeSpring also opened a full time outpatient office in Austin in July of 2015. The LifeSpring Foundation of Indiana pledged \$50,000 to help pay for psychiatric addiction services to be provided in Austin.



In addition to outpatient, psychiatric, nursing, case management, and intensive outpatient services in Austin, LifeSpring also sought approval from the Health Resources Services Administration to expand the scope of services for its FQHC to provide healthcare in Austin, Indiana. This has already been approved and LifeSpring began providing primary care service in Austin in April 2016.

In the coming year LifeSpring also plans to work with DMHA to increase access to quality Medication Assisted Treatment for people with substance use disorders in Southern Indiana.

Looking toward 2016 LifeSpring intends to continue its leadership in the march towards comprehensive integrated care and our governing board has already approved plans to include dental and oral healthcare in our service continuum and to expand FQHC access throughout the region. All of this is very promising for those most in need of access to affordable healthcare.

Joint Letter from LifeSpring Board Chair & Foundation Board President

From the both of us, we thank you for your support of the LifeSpring mission during this past year. We have done things through both LifeSpring and the LifeSpring Foundation of Indiana that are new, as well as beginning to focus on whole health. Many of our patients, for years, had inadequate access to primary healthcare and were dying at rates similar to those of third-world countries, not from mental health issues but from things like diabetes, heart disease, and other readily treatable primary care issues. We now have a facility designed for dealing with primary care.

The LifeSpring Foundation of Indiana has significantly expanded its presence in the community. It has given over \$50,000.00 to fund a satellite office in Austin, Indiana to try to provide care for those with substance use disorders. All in all, we have scheduled and produced a record number of dollars, solicited on behalf of the care of the mentally ill and those in need, and we have expanded our services. This is a bright spot. We celebrated accomplishments and commitment of those who received the Impact Awards. Last year, Judge Maria Granger, who has created a Veterans Court to deal with troubled veterans, received the Impact Award. Judge Granger has added a new level of service in cooperation with LifeSpring. St. Luke's United Church of Christ received the Community Heart Award for its many efforts and missions out in the community. St. Luke's offers a weekly meal, they do work with mental health survivors of suicide, and they present seminars for preventing suicide. Dr. Leah Dickerson has always been a positive role model for other staff at LifeSpring, and we have honored her, as well, with the LifeSpring Leader Award.

On behalf of the Board of Directors and the Foundation Board of Trustees, we thank you for your continued support.

President's Award Winners



TEODORO BORDADOR, M.D. Staff Psychiatrist

Dr. Teodoro "Ted" Bordador's journey to U.S. citizenship could accurately be described as a "long and winding road." He was born in the Philippines, when the Philippines was still a U.S Colony, and as such,

was a U.S. Citizen at birth.

A few years later, when the Philippines gained independence, he became a citizen of the Philippines, and attended Medical School at the University of St. Thomas. In 1968, he moved to Louisville, Kentucky to complete Residencies in Neurology and Psychiatry at the University of Louisville. In 1974, Dr. Joseph Brill, the founder of Southern Indiana Mental Health and Guidance Center (now LifeSpring Health Systems), hired him as a Staff Psychiatrist. He made Louisville his home, and spent the next twenty years serving our clients.



Dr. Bordador took what he describes as a "hiatus" from 1993 – 1995, but eventually returned to LifeSpring, and the work to which he has devoted most of his life. Along the way, he had five children, and although he is the ultimate University of Louisville fan, is quick to report that four of those children have degrees from Indiana University (one of these four also has a University of Louisville degree), and the fifth graduated from Ball State. He has no immediate plans for retirement, stating "I have to have a reason to get up in the morning," and he still enjoys helping the people who have depended on him for so many years. Dr. Bordador also has a distinction shared with very few of us; he has several third generation patients! But, it is not only our clients who have benefited from Dr. Bordador's dedication. LifeSpring continues to be the beneficiary of his willingness to serve wherever he is needed, and through his generosity to the LifeSpring Foundation. And, by the way, Dr. Ted Bordador, again, became a U.S. Citizen in 2013!

LIFESPRING PARTICIPATES IN HIV OUTBREAK RESPONSE

LifeSpring's strong relationship to our communities was apparent during the unprecedented HIV outbreak tied to intravenous drug use in Austin, Indiana that began in early 2015. As part of the initial and long-term responses, LifeSpring staff worked with local, regional, state, and federal officials to mobilize existing resources and to capitalize on the infrastructure already in place to provide additional substance abuse treatment services to those in Austin and surrounding areas who needed additional services closer to home.

Initially, LifeSpring provided clinical staff at the "One Stop Shop," prioritized Scott County residents for detoxification, and waived all administrative requirements for treatment entry. LifeSpring clinical and administrative leadership also participated in many meetings with local residents and leaders to determine the next steps forward.

By August 2015, LifeSpring had opened a permanent outpatient office in Austin called the Austin Medical Center. This outpatient behavioral health office provides comprehensive behavioral health and addiction treatment services to individuals of all ages regardless of ability to pay. Staff located in this facility include a psychiatrist, therapists, case managers, nursing staff, administrative staff and others. In December, the Health Resources and Services Administration approved this location as a site for a Federally Qualified Health Center, making the Austin Medical Center the second location in the LifeSpring system to provide completely integrated behavioral health and primary care services.

Since opening, the Austin Medical Center has exceeded all expectations in terms of numbers of patients served and continues to grow weekly. Dr. Terry L. Stawar, President/CEO, stated, "Austin is a community that is worth the long term investment and LifeSpring will be here for the long haul. I have been impressed by the commitment of the leaders in Austin and Scott County. We know treatment works, and we know this can be an important piece for those who need to address the disease of addiction."



New Programs in 2015

FEDERALLY QUALIFIED HEALTH CENTER

In May 2015, LifeSpring received the exciting news that the United States Department of Health and Human Services Health Resources and Administration Department had designated the agency as a Federally Qualified Health Center (FQHC). Health Centers provide access to health care regardless of an individual's insurance status or ability to pay. Centers receive funding from the Affordable Care Act and serve over 23 million Americans. LifeSpring Community Medical Services is located at the Integrated Treatment Center on Sharon Drive in Jeffersonville. This clinic focuses on serving mentally ill and homeless individuals, but anyone is eligible to receive care, regardless of ability to pay. On July 7th, the clinic officially opened and began seeing patients. Dr. Eric Yazel serves as the Medical Director for LifeSpring Community Medical Services and brings considerable public health experience from his years as an Emergency Room Physician at the Clark Memorial Hospital and University of Louisville Departments of Emergency Medicine. The clinic also employs two nurse practitioners, a registered nurse, and two medical assistants. The establishment of LifeSpring Community Medical Services results from years of hard work by LifeSpring leadership and staff to become a truly integrated health care destination for the mentally ill within the Southern Indiana community.






