Dear Friends,

On behalf of LifeSpring Health Systems and its staff, I would like to welcome you to our 2016 Annual Report. Thank you for taking time to learn more about LifeSpring and the excellent work of our more than 350 dedicated staff members. We consider it an honor to provide quality healthcare to our communities.

This December the U.S. Department of Health and Human Services informed us that we were awarded a grant to establish a second grant-funded access point as a Federally Qualified Health Center (FQHC) in Washington County, Indiana, bringing us to our third community health center site. LifeSpring already operates community health center sites in Jeffersonville and Austin, Indiana.

Plans are now underway to expand our existing Washington County office in Salem, Indiana so that we can provide primary care services there. Soon we will be operating three primary care clinics. This will go a long way towards achieving our goal of being a truly integrated healthcare system. This coming year we will also significantly expand our Jeffersonville FQHC operation, which is located in the Integrated Treatment Building on LifeSpring's Recovery Campus. In other developments, with our growing jail services program and Project 180, LifeSpring has become a statewide leader in providing forensic services and accessing the Indiana Recovery Works program.

LifeSpring has made a concerted effort to make Mental Health First Aid training available throughout our service area. We have focused on groups such as first responders and educators, as well as making this training available to the general public.

LifeSpring has also partnered with local law enforcement agencies in a special program which provides training to police on how to administer naloxone for the emergency treatment of a suspected opioid overdose. In 2016 thirty lives were saved.

This coming year we will be adding additional office space, as well as staffing, to our integrated care center in Austin, Indiana. In collaboration with the Scott County Health Department, services provided at this office are instrumental in efforts to stem the opioid abuse epidemic and associated HIV outbreak in this region.

Again, many thanks for your interest in LifeSpring Health Systems.

LifeSpring Clinical Trainer Ellen Kelley received the LifeSpring Leader Award for her initiative in finding ways to grow the Foundation as well as her passion for LifeSpring's mission.

Oh behalf of the Board of Directors and the Foundation Board of Trustees, we thank you for your continued support.



INDIANA'S FORENSIC TREATMENT PROGRAM

Recovery Works!

In the Spring of 2016, LifeSpring became the provider for a new program in the state of Indiana called Recovery Works. This is a voucher program through the Indiana Department of Mental Health and Addictions aimed at reducing recidivism and addressing the many mental health and substance use disorders that are prevalent in the criminal justice population. Within the current prison population, 16% of inmates have a diagnosed mental illness and approximately 50% have a substance use disorder, compared to the general public at rates of 5.4% and 8.8%, respectively.

Recovery Works funds behavioral health care services for individuals involved in the criminal justice system that meet specific criteria. A large portion of the clients referred through this program are recently transitioning from jail or prison and have limited resources or insurance. This program allows them to get the help needed, without barriers. Services covered include individual therapy, groups, case management, medication assistance, transportation, and sober living costs.

Through the end of 2016, 125 clients had been referred to LifeSpring through the Recovery Works program. With the leadership of Denise Poukish, Vice President for Forensic Services, our Forensics Department has made great connections with referral sources throughout Southern Indiana and we receive referrals from all six of the counties we serve. The majority come from Clark, Scott, and Jefferson County jails where we provide behavioral health services inside the jail.



Marta Myszak, LCSW



In the Spring of 1980, Marta Myszak was completing a Master's Degree and planning on a summer internship at Southern Indiana Mental Health & Guidance Center (now LifeSpring) prior to returning to her teaching job in the fall. Thirty-six years later, she is still at LifeSpring and never returned to teaching. Her career at LifeSpring progressed from Therapist, to Clinical Manager of the Washington County office, to VP for Area Services, and now Sr. VP for Clinical Services. She attributes this longevity with the organization to the people she works with, the opportunity to be involved in the community in a variety of ways, and the fact that "no two days are ever the same."

Marta is an Indiana University alumni, and an avid IU Basketball fan (no matter what). She has twin daughters, Brett and Kelsey Owen

(both are also IU grads), and 4 "grand-dogs". When not working, she enjoys walking with her dog, "Curly", quilting, reading, and gardening.

LifeSpring Partners with Green Valley Elementary School

In the fall of 2016, LifeSpring's Floyd County office began a partnership with Green Valley Elementary School in New Albany, Indiana to provide mental and behavioral health services to their students. A Therapist and Care Manager provide onsite therapy and case management weekly to students referred by the school counselor, teachers, and administrators. This clinical team works with school personnel for case collaboration and to provide consultation to teachers, supporting the overall learning environment of the classrooms.



To date, services have been provided to 20 students and their families in the form of therapy, case management, medication management, and skills-building. The clinical staff are housed on-site on separate days each week and work amongst a multi-disciplinary team comprised of the school counselor, resource officers, principal, and assistant principal. Green Valley Elementary serves approximately 300 students in kindergarten through 4th grade. The school is considered high-need, as 85-90% of students fall below the federal poverty line and there is a large student turnover each year.

Youth Crisis Intervention Teams

In August 2016, the local Systems of Care group, run by Meara Grannan, LifeSpring Vice President of Children and Family Services, received grant funding through the Indiana Department of Mental Health and Addictions for Youth Crisis Intervention Teams (CIT-Y) training. This program is intended to teach juvenile justice workers and first responders how to intervene early with youth who have mental illnesses, so as to keep them from becoming involved in the juvenile justice system. According to the National Alliance on Mental Health (NAMI), approximately 13% of youth have a serious mental illness, yet only about 20% of those get the treatment they need. Within the juvenile justice department, 70% of youth have at least one mental health condition.

The CIT-Y program includes training on topics such as active listening and de-escalation, child mental health conditions, suicide, and child abuse and neglect. Presentations have been given by local mental health therapists and psychiatrists, Department of Child Services workers, county probation staff, and school resource officers, among others. The program aims to build community partnerships, locate gaps in the current system, and address these gaps. The program will continue through June 2017.

The local Systems of Care group is comprised of social service providers in Clark and Floyd counties. This collaborative group works to create a coordinated network of services and supports that are youth-guided and family-driven, easily accessible and tailored to meet the needs of youth and families in this community. The overall goal is to increase access to mental health and substance use treatment and supportive services.

Client Resource Center a Success

These days, the Client Resource Center (CRC) is flourishing with activity thanks to the leadership of Steve Mahoney, Client Resource Center Coordinator. What used to be the Drop-In Center, a space for clients to drop by and socialize with fellow clients, has become so much more as the Client Resource Center. Adding "client" into the name has made clients now feel they have ownership and pride in their space, and in turn, attendance has blossomed. Mondays bring upwards of 60 clients, with a daily average of 35 individuals; special events can bring up to 125 clients.


A client-run co-op store was started as a way to teach budgeting and organization to clients. The co-op offers a convenient service to clients, offering items such as toilet paper, trash bags, and cat food. A Peer Council Town Hall gives clients access to the Lindley building leadership and serves as a way for them to voice any concerns. In addition to daily routine activities, monthly events are scheduled around holidays, including a monthly birthday party and a monthly "Healthy Living" seminar presented by Clark Memorial Hospital. This daily interaction with LifeSpring staff and peers allows for a healthy routine and for instant assistance from the agency and community support systems should a client begin to show signs of struggling.

With Steve's help, clients developed a mission statement that goes hand in hand with LifeSpring's own mission statement, "The Client Resource Center is dedicated to providing a safe, respectful, fun and inclusive atmosphere for LifeSpring Clients while continuing the development of ADL (activities of daily living) Skills used in everyday life." The CRC is located in the Lindley Building in downtown Jeffersonville, making it easily accessible to our many clients that live in the area.

Medication Assisted Treatment



LifeSpring received funding through the Indiana Department of Mental Health and Addictions to increase access to Medication Assisted Treatment (MAT), an evidence based treatment for individuals with a substance abuse disorder. Our program expansion targeted individuals in rural communities with substance use disorders who have a diagnosis of an infectious disease, or are at risk of one due to IV drug use. It aims to eliminate barriers such as transportation and lack of insurance for individuals in high risk areas for infectious disease such as HIV and Hepatitis C and provide access to recovery care and services.

The MAT program is housed in LifeSpring's Recovery Campuses where integrated primary care and substance abuse treatment services are offered. This allows for a whole-person model of care where in addition to MAT, services such as mental and medical health services, occupational support, case management, and coordination of care are offered. By the end of 2016, 85 individuals were enrolled in the MAT program.
