Dear Friends,

Welcome to LifeSpring Health Systems 2017 Annual Report. This has been another stellar year for LifeSpring and our caring and dedicated staff. We have continued to build on our board's visions to provide a comprehensive continuum of integrated healthcare services for all of the counties and communities we serve.

LifeSpring has implemented a newly funded Federally Qualified Health Center (FQHC) in Washington County, Indiana, by doubling the size of our Salem, Indiana facility. We have also expanded our FQHC service site in Jeffersonville, Indiana. At our Austin, Indiana, location we have added space for group rooms and offices by placing a temporary facility in the area adjacent to our current offices.

Using a Community Development Planning Grant, LifeSpring has developed a plan for a multi-service center for the Austin area. We hope to start construction on this major project in the coming year.

LifeSpring has expanded the availability of Medication Assisted Treatment (MAT) for opioid-related disorders and has increased the services provided under Indiana's Recovery Works. This is a program for people involved with the criminal justice system who are in need of behavioral health services.

Through our strategic plan, LifeSpring currently has workgroups addressing homelessness issues, community suicide prevention programs, mental health first aid, as well as substance abuse service needs, and wellness.

One of the most exciting developments this year was the LifeSpring board of directors' decision to merge with Southern Hills Counseling Center. Southern Hills Counseling Center is the community mental health center that serves Spencer, Perry, Orange, DuBois, and Crawford Counties. This is an important opportunity for LifeSpring to grow and to take advantage of the economies of scale and the synergy generated from partnering with our sister center to the West.

LifeSpring Health Systems thanks you for your interest in our organization.







A Day at LifeSpring Medical Services



Dr. Eric Yazel is the Senior Vice President of Medical Services at LifeSpring. He has the distinction of being the Clark County Health Officer,

a local emergency room physician, and also volunteers extensively with local first responders. So, it's no secret that public health is his passion, and ultimately this is what brought him to LifeSpring. Dr. Yazel writes about his first day below:

I want to tell you about my first day at LifeSpring, because my first patient really showed me that what we were doing was worthwhile and so needed. My first patient was a mid-50's newly diagnosed diabetic. The patient had been diagnosed in the Emergency Department. After the patient's blood sugar was stabilized, he was provided a prescription and some sample medications and discharged home with instructions to follow up with our practice. I saw him approximately two weeks later. By the time he saw me, he was out of his sample medications, had never filled the prescription he couldn't afford, and was dangerously close to hospitalization, or worse. My patient was employed and had insurance, it just wasn't good enough. Underinsured we call it. He was scared.

He paid \$15 for his visit with me that day, because our costs are based on income. I immediately ordered some medication to get his blood glucose level under control, and then we spent about 45 minutes together talking extensively about how to manage Diabetes. We talked about diet, exercise, medication, monitoring sugar levels... Our nurse taught him how to test his blood sugar and how to administer his medication. While this was going on, my medical assistant called pharmacies and his insurance company trying to find a prescription that he could afford. Before he left, we checked to make sure he was safe to leave, gave him his new medication samples and prescription, we scheduled an appointment with our nutritionist, and we sent him on his way.

All of this for \$15. For \$15 he got access to some of the best medical care in Southern Indiana, but the most important factor was that it was completely tailored to him. It was focused on what his medical needs were at that time, addressed what he could afford, and helped him to take control over what could be a debilitating and life threatening condition, if not managed properly. I saw him on a Thursday. It is my opinion he would have been back in the hospital before the weekend was over, probably as an inpatient. For this patient, it was the right amount of care, at the right time, in the right place.



Thanks to grant funding, LifeSpring clinical staff received intensive training on a variety of topics in 2017. Seventeen clinical employees received training in Eye Movement Desensitization Reprocessing (EMDR) thanks to funding in a grant from the Substance Abuse and Mental Health Services Administration (SAMHSA). This type of therapy is designed to treat trauma symptoms, including post-traumatic stress, by using eye movements and other forms of bilateral stimulation to help clients process distressing memories and beliefs. Most LifeSpring clients have experienced at least one traumatic event in their lives so staff will be able to use this treatment as a way to improve clients' lives. Staff devoted six days to classroom training and received 10 hours of group consultation.

This funding also allowed for Juli Alvarado, a therapist specializing in trauma care, to provide a day long training



on Mindfulness and Trauma-Informed Care. Fifty LifeSpring clinical staff members, including therapists, care managers, and technicians attend this eight hour training on how trauma affects brain development. They learned about inventions and therapeutic techniques used to help clients heal and received specific case planning for some challenging clients.

Item Drive for Homeless Closet

During the month of October, LifeSpring held an item drive for our homeless closet. Our goal was to collect winter items like hats, gloves, scarves, and socks; feminine hygiene products: and protein bars and pre-packaged food. First Savings Bank, Nicholson Printing, and Unique Management Services partnered with us and put out donation boxes. As a culmination of the drive, guests that brought an item to the Circle of Life Gala received a discount on their total auction purchase. Because of the community support, we



were able to collect and deliver four big boxes of items to our homeless closet, located at the Integrated Treatment Center on Sharon Drive in Jeffersonville.

White Flag Night

In the fall of 2017, Homeless and Housing Projects Manager, Jessica Floyd, formed a team of LifeSpring employees to support the local White Flag shelter efforts. The Homeless Coalition of Southern Indiana sponsors a volunteer-staffed White Flag Emergency Shelter for men, women, and families during inclement weather at The Salvation Army in New Albany. The shelter is opened when the temperature drops below 35 degrees. Guests have access to showers, and cots, dinner, continental breakfast, and sack lunches are provided.

Duties for the volunteers include checking in guests, providing and serving food, and ensuring guests are safe throughout the night. Patient Centered Medical Home



LifeSpring Health Systems primary care services serves as a patient centered medical home (PCMH) for our primary care patients. The PCMH is a care delivery model whereby patient treatment is coordinated through their primary care provider to ensure they receive the necessary

care when and where they need it. We work to ensure our patients receive seamless services across the healthcare system. Our team wraps services around the patient to make sure they get appropriate healthcare services, including specialty care, laboratory and radiology care, inpatient services, care coordination, language services, and anything else that may be necessary. Our primary care teams are designed around the patient's needs, so the patient doesn't have to be the one doing the difficult work of figuring out how to navigate complicated healthcare systems.

The Healthy Lives Program

In October of 2016, LifeSpring Health Systems was awarded a Primary Behavioral Health Care Integration (PBHCI) grant funded by the Substance Abuse and Mental Health Services Administration and the Center for Mental Health Services. The goal of the grant-funded program is to establish provisions for integrated services through the co-location of primary medical care and behavioral health services. The program's main objective is to support the triple aim of improving the health of individuals with a serious mental illness and/or co-occurring substance use disorders; enhance the quality, access, and reliability of care; and reduce the per capita cost of care.

LifeSpring began enrolling clients into the Healthy Lives Program in March 2017. Since its inception the program has grown substantially and has served over 220 clients. Emerging research has shown that individuals living with a serious mental illness and/or co-occurring substance use disorder have significantly higher morbidity and mortality rates when compared to the general population. Many of the physical illnesses that cause these higher rates of morbidity and mortality are preventable with routine primary care screenings, case management services, health promotional activities, and outreach strategies.

The Healthy Lives Program uses several avenues to support the triple aim of improving health, enhancing care and reducing the per capita cost of care. The program currently staffs Peer Recovery Coaches who handle case management, peer support, and educational

groups. A Nurse Care Manager is available to provide one-on-one health education to clients, in addition to coordinating with outside primary care providers.

The Healthy Lives Program brings together existing curriculums and new programs to improve health across Southern Indiana in order to help our clients live happier, healthier lives. Our program works alongside community partners to offer a unique variety of health promotion and fitness activities. The following are community partnerships that have developed since the program begun: Clark County Tobacco Coalition, Purdue Extension, Floyd County Tobacco Coalition, Community Action of Southern Indiana, and Clark Memorial Hospital.
